

The envelope shall be super scribed with "TENDER FOR A.M.C. OF INTER COM SYSTEM" and it must reach us **on or before 23/05/2017 upto 12.00 noon.** Sealed tenders will be opened on **23/05/2017 at 4.00 p.m.** in the presence of all tenderers.
- 3) Sealed Tenders received after due date and time will not be entertained.

- 4) The rates quoted shall be inclusive of all taxes and shall be valid for two years and the AMC Charges will not be enhanced by the Vendor/agency in any case during the period of two years.
- 5) The Academy does not pledge itself to accept the lowest or any tender and also reserves itself the right of accepting the whole or any part of the tender or portion of the tender.
- 6) In case of any disputes arising in respect of the said quotation/tender, the dispute will be solved through arbitration and the contractor/tenderers will have to abide by the decision of the arbitrator. The arbitrator will be appointed by the Maharashtra Judicial Academy. Further, the contractors/tenderers will have to submit an undertaking to the effect that they shall agree to the settlements of disputes through such arbitration and they bind themselves to go by the decision of the arbitrator.
